Subject: REVISION OF RENTAL CEILING OF SELF HIRED RESIDENTIAL ACCOMMODATION (HOUSING SUBSIDY)

Dear Sir,


I am directed to refer to this Department letter of even number dated 29/05/2008 on the subject noted above and to state that certain conditions have been set forth therein for grant of housing subsidy, one of which is provision of ownership documents of the house/land (Mutation/Registered deed).

In this connection, it may be clarified that exclusive ownership of the property/accommodation is a pre-requisite to claim housing subsidy for a house. No Housing Subsidy will be allowed in cases where house is co-owned/shared by others with the applicant. Henceforth Government Servants shall be required to append a certificate of exclusive ownership duly attested by his controlling officer with the application for sanction. Government Servants already in receipt of Housing Subsidy shall be served notices to provide a certificate of exclusive ownership within one month failing which the facility shall be withdrawn.
