The NFC ADVISER will be placed in NFC Support Unit of Finance Department. The minimum qualification for the applicants shall be Master Degree or equivalent in the fields of Economics, Commerce, Statistics, Accountancy, Public Administration, Public Policy or Business Administration with a sound track record of minimum post qualification experience of not less than 25 years in Federal or Provincial Governments or Public Sector Organizations, including at least three years in handling of public finances, development planning or inter-governmental fiscal transfers at policy level. The applicant's experience as Administrative Secretary and exposure to working of Federal and Provincial Governments, and matters relating to National Finance Commission and its working mechanism would be given due weight age. The maximum age limit of the applicants should not be more than 65 years on closing date of the advertisement. The salary of the position would be at par with MP-I scale along-with other fringe benefits. ## **JOB DESCRIPTION OF NFC ADVISER**

- a) Review of international practices on inter-governmental transfers
- b) Review of past NFC Awards and their impacts on provincial resources
- c) Preparation of thematic papers, like allocative efficiency etc., for sharing and consideration in NFC
- d) Proposals for broadening of Federal Divisible Pool and safeguards against exclusion of legitimate resources from the pool
- e) Rationalization of vertical distribution in light of 18th Amendment, including factoring in additional burden of the devolved services/ offices on the Provinces
- f) Identification of suitable Indicators favorable to the Province and simulations thereof in the context of fiscal equalization, lag in infrastructure/ lag in development, poverty level
- g) Preparing a case for distribution formula based on suitable multiple factors and its weights
- h) Analysis of cost of conflict and impacts of war against terror and demand for its composition
- i) Collection of statistical data and analysis for usage in the distribution formula, through all available sources, including NADRA and BISP
- j) Preparing case for optimization of straight transfers
- k) Preparation of defence against adverse impact of the pleas and claims of other provinces
- l) Preparing a case for Non-NFC issues which might be tied with NFC, including NHP, funding for meeting MDGs, funding higher education, Internally Displaced persons and outfalls of FATA issues
